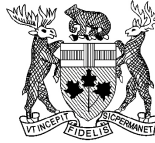

1. ACCESSIBLE PARKING PERMIT REQUIRED

Parking of Vehicles within a designated Accessible Parking Area is prohibited without an authorized Permit as per Part 3 Section 3.7 (a) and (b) of this By-law.
