

By-law 20-2023

THE CORPORATION OF THE MUNICIPALITY OF WEST PERTH

Being a By-law to amend By-law 16-2023, being a By-law to appoint members to the various Boards, Committees, and Authorities in the Municipality West Perth

Whereas Section 5 (3) of the *Municipal Act, 2001*, as amended, provides that a municipal power, including a municipality's capacity, rights, powers, and privileges under Section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

Whereas Section 8 of the *Municipal Act, 2001*, as amended, confers broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues

Whereas Section 97(1) of the *Drainage Act, R.S.O. 1990, c. D.17*, as amended, authorizes municipal councils to appoint members to the Court of Revision; and,

Whereas the Council of The Corporation of the Municipality of West Perth deems it expedient to appoint persons to provide for and assist in the administration, protection and management of the Municipality;

Now therefore be it resolved that the Council of the Corporation of the Municipality of West Perth enacts as follows:

1. That the Schedule "A" attached to By-law 16-2023 be replaced in its entirety with the Schedule "A" attached hereto and is hereby adopted and forms and integral part of this By-law.
2. This By-law shall come into full force and effect on the final date of passing.

Read a first and second time this 1st day of May 2023.

Read a third and final time and finally passed this 1st day of May 2023.
