**Decision**

Under the authority of **Part VI.1 (Special Powers and Duties of Head of Council)** of the *Municipal Act, 2001*, I, as Mayor of the Municipality of West Perth, hereby issue the following decision:

**Details of Decision:**

To give written notice for the approval of by-laws.

1. The Mayor will not exercise the power to veto the following by-laws, passed at The January 26, 2026, Regular Council meeting:
  - By-law 71-2025, being a By-law to provide for drainage works in the Municipality of West Perth in the County of Perth – Cook Municipal Drain Branch '2', 'D', and 'E' 2025.
  - By-law 8-2026, being a By-law to provide for drainage works in the Municipality of West Perth in the County of Perth – Campbell-Hussel Municipal Drain 2025.
  - By-law 9-2026, being a By-Law to authorize the execution of an agreement of purchase and sale of Block 10, Plan 548 Fullarton, being all of PIN 53219-0027 (LT) in the Municipality of West Perth.
  - By-law 10-2026, being a By-Law to authorize the execution of an agreement of purchase and sale of Part of Lot 22 Registrar's Compiled Plan 478 Mitchell, being Parts 3 & 4, 44R-6066; subject to an easement over Part 3, 44R-6066 as in R84493, being part of PIN 53193-0025 (LT) in the Municipality of West Perth.

- By-law 11-2026, being a By-law to exempt from Part Lot Control Plan 44M-95, Lot 15, Mitchell, in the Municipality of West Perth being all of PIN 53188-0728 (LT)
  - By-law 12-2026, being a By-law to Exempt from Part Lot Control Plan 44M-95, Lot 16, Mitchell, in the Municipality of West Perth being all of PIN 53188-0729 (LT)
  - By-law 13-2026, being a By-law to Exempt from Part Lot Control Plan 44M-88, Lot 4, Mitchell, in the Municipality of West Perth being all of PIN 53200 0406 (LT).
  - By-law Z318-2026, being a By-law to amend By-law No. 100-1998, as amended, for a property legally described as Part Lot 22, Concession 12, Fullarton, in the Municipality of West Perth.
2. This Mayoral Decision provides written notice to approve the above by-laws.
  3. This Mayoral Decision comes into effect on January 26, 2026.
