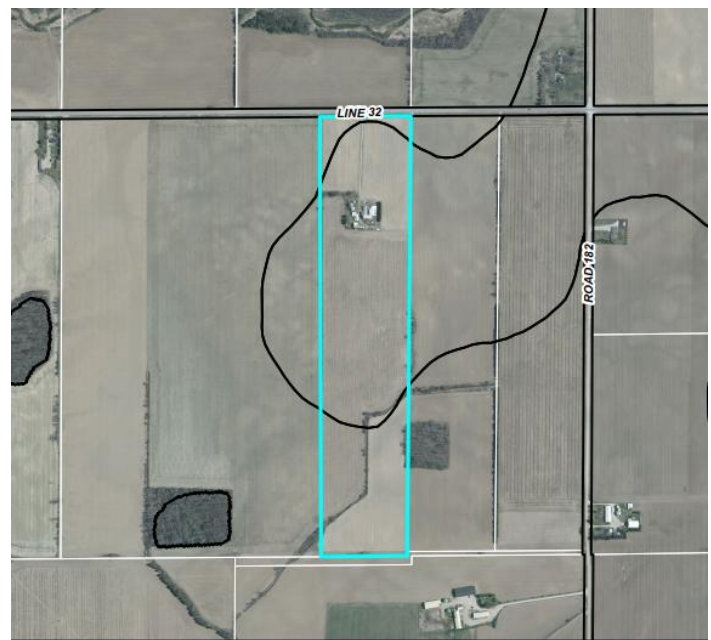

The subject lands are approximately 21 ha (52 ac) in size and contain multiple farm implement buildings.

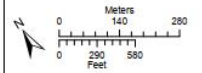
