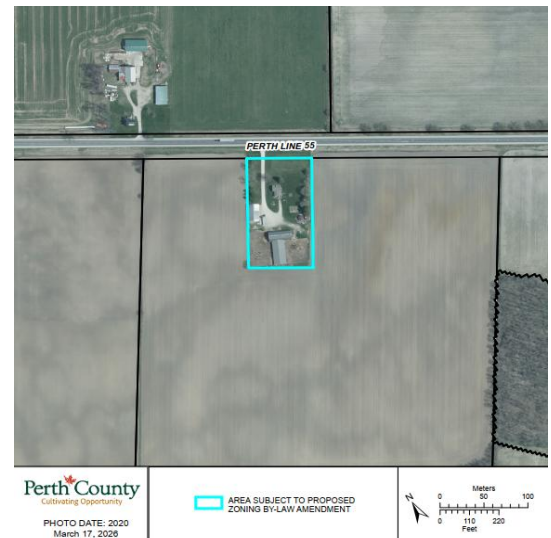

TAKE NOTICE a proposed Zoning By-law Amendment application has been received affecting the property described above. The application was deemed complete on May 15, 2026 pursuant to Section 34 (12) of the *Planning Act*, R.S.O. 1990, amended.

Purpose and Effect: The application for zone change is proposing to amend the existing A-1₁₀ Zone to permit a 300-feeder goat operation (9.4 NU) as an accessory use to the residence, and to reduce the Minimum Distance Setback II requirement for manure storage from the nearest lot line (rear yard) from 9 m to 3 m.

The subject lands were created by surplus farm dwelling severance via Consent Application B45-23 and subsequently rezoned via ZN 6-2024 to recognize the residential nature of the lot.
